Individuals must be legally recognized by the appropriate state regulatory agency prior to practicing athletic training. The BOC exam is recognized by all Athletic Trainer state regulatory agencies to meet their exam requirement. Compliance with state regulatory requirements is mandatory and the only avenue to legal athletic training practice. Explanations of Types of State Requirements	<p>State Certification- A voluntary process by which a practitioner's entry-level knowledge and skills are demonstrated and measured against a defined standard. The BOC is the only National Commission for Certifying Agencies (NCCA) accredited certification program in the U.S.</p> <p>Licensure- Regulated process established by statute whereas it would be illegal for an individual to practice without a license.</p> <p>Registration- by providing the athletic trainer's name, business address, a current, active, and unencumbered certification from the Board of Certification, Inc., including the certification number, and information on any complaints filed against the athletic trainer with the Board of Certification, Inc., or with any state agency that regulates athletic trainers, including the status and disposition of all complaints.</p>

The student maintains certification through the Board of Certification with recertification requirements every two years and follows each states practice act in regard to athletic training.
